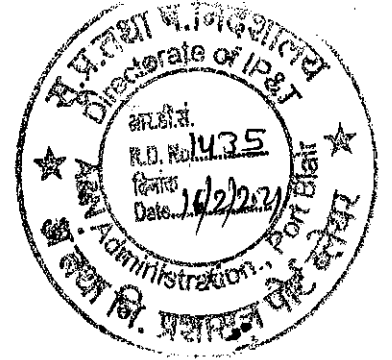

1. The vehicle will be disposed off in its present condition on "as is where is basis".
2. The minimum assessed price or reserve price is fixed of ₹60,000/-. The tenderer(s) should not quote below the fixed minimum assessed price or reserve price.
3. The tender accompanied with bid security of ₹6,000/- (Rupees Six Thousand Only) in the form of DD drawn in favour of the Special Resident Commissioner, Andaman & Nicobar Bhawan, 12 Chanakyapuri, New Delhi-21, payable in Delhi from any Nationalized Bank should be submitted to the Special Resident Commissioner, Andaman & Nicobar Administration, 12, Chanakyapuri, New Delhi-21 on or before 01-03-2021 upto 03.00PM and the same will be opened on the same day at 03.30PM.
4. The tenderer(s) may inspect the vehicle and satisfy themselves about its present condition at any time during office hours on all working days in the office of the Resident Commissioner, Andaman & Nicobar Administration, Andaman & Nicobar Bhawan, 12-Chanakyapuri, New Delhi-21.
5. The tender received without EMD will summarily be rejected.
6. The bid security in case of unsuccessful tenderer will be released immediately, except that of highest and second highest tenderer.
7. The consolidated result and acceptance of the highest tender will immediately be communicated on the same day.
8. The highest bidder is required to deposit 100% of the amount offered by him in cash immediately after opening of tender on the spot to the Cashier, Accounts Section, A&N Administration, New Delhi.
9. The amount deposited by the highest bidder shall be remitted to the Sr. Accounts Officer (IP&T), Directorate of Tourism, Andaman & Nicobar Administration, Port Blair by way of Demand Draft.
10. Delivery order will be issued to the tenderer on receipt of the communication of full payment of the bid.

11. If successful tenderer fails to deposit the full bid amount is liable to be forfeited Security deposit by the Resident Commissioner, New Delhi. Thereafter the vehicle will be disposed off in the manner as may be decided by the Administration.
12. No claim whatsoever on this account will be entertained by the Resident Commissioner, New Delhi once the final decision is conveyed to the concerned party.
13. In case the date of opening of tender is declared as Public holiday, the tender shall be opened on the next working day at the same time.
